



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as "MoU") entered into on this 22nd day of Dec 2020 by and between:

National Highways Authority of India (NHA) which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assigns), of the First party;

AND

The **Siliguri Institute of Technology, Salbari, Sukna, Siliguri-734009** (hereinafter called as **The Technical Institute** which the expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assigns) of the Second Party.

WHEREAS,

Both **the Technical Institute (TI)** and NHA are desirous of working together with mutual cooperation for dissemination of respective expertise in civil/highway engineering field through the road infrastructure development.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES AS FOLLOWS:

1. INTENT:

National Highways Authority of India (NHA) intends to associate the **TI** who shall voluntarily contribute its share of experience for betterment of the highway infrastructure.

2. SCOPE OF THE MOU


The primary scope of MOU inter alia includes the following:


(i) NHA shall facilitate the faculty, researchers and students of the Institute to familiarize with the latest trends in the highway/transportation/bridge engineering/structural engineering/Geotechnical Engineering sector with a common objective of sharing the knowledge in their respective domain which may lead to joint supervision of Ph.D research and projects of postgraduate students. This will, in one hand, facilitate to bridge the industry institute gap and familiarize students with the latest trends in industry and on the other hand the research output could be suitably adopted in practice by NHA and the Technical Institute.

(ii) The Institute shall adopt nearby stretches of NHs as specified in the **Appendix-1** as a voluntary initiative under ambit of Institutional Social Responsibility (ISR). **The list of stretches may be modified by deletion/addition by mutual consent of NHA and the Technical Institute.**

(iii) The adopted stretch may be used as a field of study for faculty researchers and students.

(iv) NHA shall offer internship to **20 number of undergraduate/postgraduate** students of the Institute for 2 months duration in a year extendable from time to time.

(v) NHAI shall pay stipend @ Rs.8,000/- (Rupees Eight Thousand only) per month for Undergraduate students and @ Rs. 15,000/- (Rupees Fifteen Thousand only) per month to Postgraduate students. All other arrangements including stay shall be responsibility of the Institute. However, depending upon availability, NHAI may extend transportation facility to the interns within the project jurisdiction.

(vi) Both the parties may form joint research groups leading to students projects at different levels and collaborative research programmes.

(vii) Both the parties may jointly organize events such as seminars, workshops, conferences and training programmes.

(viii) No party shall have the right to use the name or logo of the other party without the prior approval of that party in writing.

(ix) The terms of this MoU may be modified/amended at any time subject to mutual written agreement. Such modifications/changes shall be effective from the date on which both the parties execute them in writing.

(x) Any other research collaboration not covered above, shall have separate agreement/terms of contract that addresses issues such as Intellectual Property Right (IPR), funding pattern, disclosure of confidential information etc.


(xi) Any other matter(s), as mutually agreed, which are not covered above.

3. Roles and Responsibilities:


The scope of this MOU shall be carried out in a collaborative mode between NHAI and the Technical Institute. The Roles & Responsibilities of NHAI and the Technical Institute in performing the defined objective shall be as follows:

NHAI

- a. NHAI shall provide the list of potential candidate National Highway for adopting by the Technical Institute.
- b. NHAI shall facilitate availability of relevant data required with specific reference to the above stretches through its field office/consultant/concessionaire/contractor engaged in the project.
- c. NHAI will nominate an officer as a Node of contact for all correspondence in carrying out the defined objective.
- d. NHAI shall facilitate the faculty, researchers and students of the Institute to give access to the site of the identified stretch being adopted by the Technical Institute, relevant documents for the purpose of activities to be carried by these intellectuals of the Institute.



- e. NHAI through its field office/Consultant/Concessionaire/Contractor engaged in the project, as per reasonable requirement, will disseminate and familiarize the latest trends and know how in highway/transportation/bridge engineering/structural engineering/Geotechnical Engineering(s) sector in general and the identified project in specific to the authorized faculty, researchers and students of the Institute;
- f. NHAI may suitably adopt the research output and feedback received from the Technical Institute in practice for qualitative improvement as deemed fit at appropriate stage of implementation.
- g. NHAI may support creation of Lab infrastructure in the Institute and can sponsor relevant research project that helps in using alternative resource material and improving quality of roads/bridges.
- h. The NH stretch adopted can be co-branded with the associated technical institute by NHAI


The Technical Institute

- a. The Institute shall adopt stretches of NHs as specified in the **Appendix-1** as a voluntary initiative.
- b. The Technical Institute through its authorized faculty, researchers and students will carry out periodic investigation on formal demands/intimation and give suitable suggestions for improving the efficiency of existing highway asset covering the following aspects:
 - (i) Improvements in safety provision by removing existing deficiencies;
 - (ii) Improvements in continual existing maintenance of the stretch using new alternatives/technologies;
 - (iii) Localized solutions for removal of congestion points, if any, so as to increase the average speed of traffic flow;
 - (iv) Improvements in the riding comfort through cost effective measures, if required, based on innovative technologies on practices applicable in the area;
 - (v) Viability of new way side amenities for road user based on the existing traffic pattern and user expectations;
 - (vi) Potential and probable solutions to old recurring problems based on local experience etc., wherever applicable.
 - (vii) Improvements in structural performance of bridges using new technologies;
 - (viii) Any other matter(s) such as structural performance audit of bridges, implementation of new innovative alternative technologies and construction materials, etc. on mutual agreement, which are not covered above;

c. The Institute may also associate with the Consultant/NHAI during conceptualization, design and project preparation of new projects and suggest the relevant parameters and innovations based on experience specific to the site climate, topography and resource potential for better socioeconomic outcome.



d. The Technical Institute will nominate a nodal officer for all correspondence in carrying out the defined objective as well as inform from time to time.


4. EFFECTIVE DATE AND PERIOD OF MOU

8. Increased exposure and speedier adaptation to the best practices.






C. General Provisions

5. The Siliguri Institute of Technology (SIT), Salbari, P.O. Sukna- 734009, West Bengal will not have financial obligation.

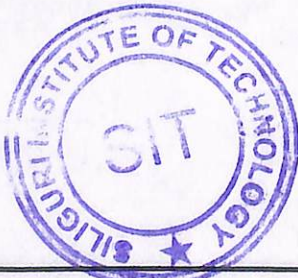

MEMORANDUM OF UNDERSTANDING

Salbari, Sukna, Darjeeling - 734009 and having its Corporate Office at Techno India (2nd Floor), EM-4/1, Sector-V, Salt Lake, Kolkata-700091, India;(hereinafter referred to as “DEESIT”) through its DEAN (E&T) Prof. Dr. P. K. Adhvaryu which expression shall, unless repugnant to the subject or context, mean and include its , affiliates and associates, successors and permitted assigns;

WHEREAS:

- A. The parties hereto share a common interest in many academic and educational fields; and
- B. In order to facilitate future mutual institutional cooperation, the parties hereto wish to enter into this Memorandum of Understanding (“MOU”).

NOW THEREFORE, the parties hereto agree as follows:

1. Objective.

The objective of this MOU is to outline the possible ways in which UAV and DEESIT, could develop and carry out collaborative activities in academics and research.

2. Scope of Activities.

The scope of collaboration on academic and research activities under this MOU may include, but is not limited to the following:

- a) exchange of faculty members
- b) undergraduate and graduate students exchange for the purposes of summer internship, dissertation projects and/or for other academic purposes
- c) Exchange of publications, research materials, newsletters, etc.
- d) Internships & Joint projects
- e) General academic and research collaboration

3. The point of contact for the duration of this MOU for DEESIT will be Prof. Jayanta Bhusan Basu (HOD, Department of Electrical Engineering – hod_ee@sittechno.org) or any other person appointed in his place by DEESIT. The point of contact for UAV will be Prof. Dr. Valentina Emilia Balas or any other person appointed in his/her place by UAV.

4. Both institutes will respect the intellectual property rights of each other during the period of this MoU.

5. Permission is given to DEESIT to use the official marks of UAV, specifically the institutional name and/or institutional logo solely for the purposes of promoting and administering the collaborative activities between the institutions; provided, however, the DEESIT shall comply with partner university policies.

Specific initiatives may be considered and agreed upon, on a case to case basis, including the contributions and obligations of each institution. Each such initiative shall be negotiated between the Parties and have the mutual agreement, and shall be formalized by a signed appendix to this MOU.
 7. **Term.** This MOU is effective for a period of 3 years from the date the MOU is signed by both parties. It may be extended or amended with the written agreement of both the parties and may be terminated by either party with 6 (six) months' written notice to the other party. MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN
SILIGURI INSTITUTE OF TECHNOLOGY (SIT), SUKNA, WEST BENGAL
AND

CENTRE FOR COMPUTERS AND COMMUNICATION TECHNOLOGY (CCCT), CHISOPANI

The MOU is entered into on the 15th day of Sept. 2018 by and between Centre for Computers and Communication Technology (hereinafter called CCCT) situated at Chisopani South Sikkim-7373126 an institute under Directorate of Technical Education, HRDD Department, Govt. of Sikkim.

AND

Siliguri Institute of Technology (hereinafter called SIT, Sukna) situated at Sukna, West Bengal, Pin-734009, an Engineering College under Techno India Group affiliated to MAKAUT and accredited by All India Council of Technical Education.

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

1. Objectives of MOU

The objectives of the MOU are:

- a) To promote and enhance academic interest between CCCT and SIT
- b) To provide advice for implementation of quality education at CCCT
- c) To encourage bright students of CCCT to come for Graduate educator at SIT.
- d) To promote research/Project/qualification up gradation activities between two institutions/departments.

2. Areas of Collaboration: Collaboration would augment both for Students and Faculty.

A. Student Related :

The following points are emphasized regarding the holistic development of the students of either institute. The points are written as here under.

1. Academic resource sharing (Laboratories exposure).
2. Joint conduction of Technical Quiz, Symposiums, Workshop, Conference with Joint certification
3. Guest /Expert Lecture on specialized area/topic.
4. Students/faculty visit to each other's department/Institute.
5. Assistance on arrangement of resource personnel from various parts of country.
6. Invitation to each other (Faculties/Students) in various departmental/intuitional activities.
7. Placement (if there is requirement of Diploma).
8. Finishing school training.
9. Arrangement of Industrial/Institutional tour of CCCT students in Industries associated with SIT.
10. Joint supervision of Student's Project executions and External/internal examiner for projects evaluations.
11. Library and LRUC resource sharing.
12. Sharing the specification/data of new equipments for purchase or training.

B. Faculty Related :

1. Enrolment of CCCT faculties in B.Tech, M.Tech and Ph.D through in service procedure (Sikkim State Government Sponsorship).
2. Partnership in R&D Projects and faculty sharing.
3. Laboratory Instrument calibrations and enhancement of skill by utilizing the infrastructure of the either institute based on availability.
4. Feedback on curriculum revision process.

3. Proposed Modes of Collaboration

CCCT and SIT propose to collaborate through the following:

- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between CCCT and SIT.
- c) A specific plan will be worked out by the institutes depending upon availability of resources.

4. Terms of Agreement :

- a) For activities mention in (A) SL No.1-12, expenses of CCCT Students and faculty shall be borne by CCCT on mutually agreed terms which will be communicated before each activity.

- b) For qualification up gradation to CCCT faculties and students, the admission arrangements will be made on mutually agreed terms depending on the existing/revised norms of each institute however faculties and students will have to borne the cost of entire course fee themselves.
- c) The faculty members and students of CCCT can use the library facility/LRUC/Internet and other resources of SIT on share basis whenever required without cost involvement and vice-versa. Both institutes may decide who will bear the expenses or a nominal fee can be taken from the students.
- d) Usage of academic infrastructure can be allowed for limited period subject to its availability i.e. without hampering the routine activity of the institute and approval of Head of facility/department and as per institute norms.
- e) Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short term courses on mutually agreed terms.
- f) Either institute shall have the right to terminate this MOU upon 60 days prior written notice to the other institute.
- g) Expenses in faculty related activities in B (SL no 1) will be borne by individual faculties upon discount rate as per norms/Government rule.
- h) Cost for B (SL no 2-4) may be borne on mutual agreement and requirement.
- i) If SIT and CCCT avails any centrally sponsored schemes (CSS), fund may be extended to support above activities depending upon nature of Schemes.

5. Confidentiality

- a) The CCCT and SIT agree to hold in confidence all information/date designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- b) The above confidential clause under this MOU excludes the information/date possessed by either institute before entering into this MOU or independently developed and / or information already available in public domain.

6. Duration of MOU

The MOU, unless extended by mutual written consent of the institutes shall expire in five years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another two years by mutual consent.

7. Coordinators

Both institutes will designate persons who will have responsibility for coordination and implementation of the agreement.

8. Intellectual Property Rights.

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.
