This Memorandum of Understanding ("MOU") is entered into and effective as of **03<sup>rd</sup> day of April 2023**.

***Between***

**Atal Incubation Centre AIC T-HUB Foundation** (hereinafter referred to as "**AIC T-HUB**"), a Company registered under Section 8 of Companies Act, 2013, having its registered office at Plot No 1/C, Sy No 83/1, Raidurgam panmaktha, Near Hitech City, Ranga Reddy District, Hyderabad, Telangana – 500081, represented by Mr. Rajesh Kumar Adla, Chief Executive Officer (AIC) (which expression shall, unless repugnant to the meaning or context thereof, be deemed to include its executors, representatives, administrators, successors and assigns) of the FIRST PART

***And***

**Siliguri Institute of Technology** (a Unit of Techno India Group), is a private educational institution situated at Salbari, Hill Cart Road, PO - Sukna, Siliguri District, Darjeeling, West Bengal- 734009, (hereinafter referred to as "**SIT**" which expression shall, unless repugnant to the meaning or context thereof, be deemed to include its executors, representatives, administrators, successors, and assigns) of the OTHER PART

"Party" shall mean either **AIC T-HUB or SIT** and "Parties" shall mean all four Parties **together**.

**WHEREAS:**

- a. AIC T-HUB strives on creating innovation ecosystem and driving entrepreneurship focusing on incubation, acceleration and facilitating market access to the start-ups and on promoting the start-up ecosystem by providing mentoring, advisory and financial support to entrepreneurs and start-ups through its network of corporates, mentors and investors and organizing various programs.
- b. SIT focuses to impart quality technical education for holistic development of students who will fulfil the needs of the industry/society and be actively engaged in making a successful career in industry/research/higher education in India & abroad.
- c. The parties herein wish to develop industry institute association for mutual benefit towards student, faculty, and facility development.

The Parties enter into this MoU on the terms and conditions set forth hereafter:

**1. Objective of the MoU**

An intent to collaborate is established by this MOU. In compliance with legal regulations, and adhering to the principles of equality, mutual benefits, mutual trust, mutual assistance and complementary advantages, both organizations agree to work towards a long-term mechanism to promote cooperation in innovation ecosystem, supporting technology driven startup companies and thus creating a holistic ecosystem for advancements in innovation in the country.

Both Parties are to cooperate with each other to facilitate effective utilization of intellectual capabilities and market reach as promptly as is responsibly practical.

## **2. Commercial engagements**

If there are any commercial engagements that comes up during the tenure of this MoU, the terms & conditions of the same shall be separately discussed and documented through a separate Agreement.

Further, if the Partner intends to run any similar program/workshop for the benefit of the ecosystem, the same shall be chargeable upon mutual agreement.

## **3. Third Party beneficiary rights**

The parties do not intend to create in any other individual or entity the status of a third-party beneficiary, and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained in this MOU shall operate only between the parties to this MOU and shall inure solely to the benefit of the parties to this MOU. The provisions of this MOU are intended only to assist the parties in determining and performing their obligations under this MOU. The parties to this MOU intend and expressly agree that only the parties signatory to this MOU shall have any legal or equitable right to seek to enforce this MOU, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this MOU, or to bring an action for the breach of this MOU.

## **4. Independent Contractors**

It is expressly agreed that the Parties shall be independent contractors and that the relationship between the Parties shall not constitute a partnership, joint venture or agency. Neither Party shall have the authority to make any statements, representations or commitments of any kind, or to take any action, which shall be binding on the other Party, without the prior consent of such other Party. Use of word "Partner" throughout this MoU is for the reference purposes and doesn't create a partnership relationship under the law.

## **5. Areas of cooperation**

### ***AIC T-HUB's offerings***

- a. AIC T-HUB may provide technical expertise, platforms and services to support institutional or departmental events like hackathons or workshops.
- b. AIC T-HUB may provide authorized experts to deliver webinars or seminars or workshops in emerging technologies or other areas of mutual interest. These activities can be made available to currently enrolled students for motivational purposes or for technology awareness.
- c. AIC T-HUB may provide support for advanced students to undertake projects in emerging technologies and gain appropriate certifications on its platform.
- d. AIC T-HUB may provide opportunities for certified internships to students from time to time. Such opportunities will be located at either its own offices or those of its partners or online.
- e. AIC T-HUB may provide assistance and opportunities for Full Time Employment to students with advanced certifications on its platform.

- f. AIC T-HUB may appoint authorized experts/resource persons to provide consultations for curriculum development and innovation or pre-incubation policies.

#### ***Expectations from the Partner***

- a. SIT may provide support to publicise AIC T-HUB offerings and events within its student community and faculty members.

#### **6. Validity**

This MoU shall be valid for a period of 3 (three) years from date of execution and as long both Parties are meeting their responsibilities as mentioned in clause 5 above.

#### **7. Dispute Resolution**

In the event of any dispute or difference or question arising between the parties out of or in relation to or in connection with this MoU, both parties shall first attempt to amicably resolve their differences or disputes on the questions arising by mutual discussion within a period of one month. Upon failure of the parties to reach an amicable settlement, Parties agree that a dispute be submitted for final award to arbitration proceedings as per the Indian Arbitration Act. Hyderabad, Telangana will be the venue of the arbitration proceedings and the arbitration will be held in the English language.

This MoU is governed by, and is to be construed in accordance with, the laws of India, without regard to its conflict of laws principles.

#### **8. Trademarks**

Neither Party shall use other's name, trademark, logo, or other markings outside its organization without express written consent of the other Party, which may be withheld by the Party owning the same at its sole discretion. Provided that the either party may use Other Party's name for credential purposes along with respective Party's prior written approval. In the event such approval is granted, any use of either Party's trademarks shall be done in accordance with the guidelines provided by the respective Parties and both Parties shall not do anything which would negatively impact trademark, legally or reputationally of the other Party.

#### **9. Confidentiality:**

Parties have agreed to hold in confidence all shared information/data designated as "Confidential", without explicit consent. This excludes prior information available with either Party or available through public domain.

#### **10. Termination**

Subject to Clause 6 above, either Party may terminate this MoU with advance notice of 1 month, in writing, and cannot be held liable, in anyway whatsoever, if the objectives cannot be achieved. In the event of termination, any information gained from either Party by way of technical processes, and procedures in any published or verbal format shall be

bound by the terms of Non-Disclosure Agreement as executed between the parties.

## 11. NOTICES

Any notice required or permitted to be given to a party under this MoU shall be in writing, shall be sent by post (registered or certified with postage prepaid), overnight courier of recognized international standing, personal delivery, or fax (if appropriate confirmation is received), or electronic mail (email) and shall be deemed to have been given when delivered:



## 12. Entirety

The Parties enter into this MoU on the terms and conditions set forth hereafter:

**Clause 1 : Objective:**

Both Parties are to cooperate with each other to facilitate effective utilization of intellectual capabilities and market reach as promptly as is responsibly practical.



**Clause 2 : Scope:**

- a. **SILIGURI INSTITUTE OF TECHNOLOGY** may provide support to publicize RG Technologies offerings and events within its student community and faculty members.
- b. **RG Technologies** may provide technical expertise, platforms and services to support institutional or departmental events like hackathons or workshops.
- c. **RG Technologies** may provide authorized experts to deliver webinars or seminars or workshops in emerging technologies or other areas of mutual interest. These activities can be made available to currently enrolled students for motivational purposes or for technology awareness.
- d. **RG Technologies** may provide support for advanced students to undertake projects in emerging technologies and gain appropriate certifications at RG Technologies office / SIT Campus.
- e. **RG Technologies** may provide opportunities for certified internships to students from time to time. Such opportunities will be located at either its own offices or those of its partners or online.
- f. **RG Technologies** may provide assistance and opportunities for Full Time Employment to students with advanced certifications on emerging technologies.
- g. **RG Technologies** may appoint authorized experts / resource persons to provide consultations for curriculum development and innovation or pre-incubation policies.

**Clause 3: Confidentiality:**

Either Parties have agreed to hold in confidence all shared information / data designated as "Confidential", without explicit consent. This excludes prior information available with either Party or available through public domain.

**Clause4: Intellectual Property Rights (IPR):**

The IPR that may arise as a result of joint research or collaborative activities under the agreement will be worked out on a case-by-case basis and will be consistent with officially laid down IPR policies of the two organizations. However, in the absence of an explicit contract, this MoU does not imply or transfer rights to reverse engineer, use, own or license intellectual properties of either parties.

**Clause5: Commercial:**

There is no financial commitment on either Parties arising from this MoU. If there is any financial consideration, It will be explicitly dealt with on a case-to-case basis.

**Clause6: Validity and Jurisdiction:**

This Agreement shall commence upon the date of the final signature below and will be valid for 3(Three) years until it is expressly terminated by either Party on mutually agreed terms. The MoU may be renewed by mutual agreement between the Parties.

**Clause7: Arbitration:**

This MOU shall not be legal binding on any of the Parties. However, In case of any dispute regarding the MOU, the parties will attempt to resolve the matter amicably any divergence or difference.

Derived from the interpretation or application of the MoU shall be resolved by arbitration between the Parties as per the Arbitration Act, 1996 under Siliguri / Kolkata Jurisdiction.

**Clause8: Relationship between Parties:**

It is expressly agreed that the Parties are acting under this MoU as independent contractors, and the association established under this MoU shall not be construed as a partnership or joint venture.

### **AND**

**Siliguri Institute of Technology**, a College located at Siliguri Institute of Technology, S.I.T. Campus, Salbari, Hill Cart Road, P.O: Sukna, Siliguri, Dist: Darjeeling, 734009, West Bengal, India (herein referred to as the "**Partner Institute**" which expression shall, unless it's repugnant to the meaning or context thereof, be deemed to mean and include its successors in interest and permitted assigns).

Foundation and Partner Institute shall hereinafter individually be referred to as a "Party", and collectively as the "Parties", as the context may require.

### **WHEREAS:**

- A. The Foundations main objectives are entrepreneurship development, to build and enhance the entrepreneurship ecosystem and for skilling through various modes of workshops, trainings etc. Wadhvani Operation Foundation (WOF)/Wadhvani Foundation (WF) has procured and/or developed world class curricula, content and methodology for its objectives (hereinafter referred to as "Wadhvani Curricula, Content and Methodology"). The details of "Wadhvani Curricula, Content and Methodology" include all the program(s) mentioned in this MoU. WOF/WF provided all the rights to the Foundation for the use and offer the "Wadhvani Curricula, Content and Methodology" to its partner institutes, who are willing to cooperate for the objectives of WOF/WF.
- B. The Partner Institute's main objective is to facilitate and promote skill, entrepreneurship and skill-based education. Partner Institute is interested in cooperating with the Foundation to further this goal. A formal approval letter is signed by Partner Institute on **{ApprovalLetterDate}**, is part of this MoU and attached herewith as **Annexure I – Formal Approval Letter**

**NOW THEREFORE** The Parties agree that this MoU shall be non-binding in nature and does not create any legal or financial obligations between the Parties, except for the Intellectual Property Rights, Data Privacy and Protection, Confidential Information,



Dispute Resolution and Indemnity provisions under this MoU. The Partner Institute and Foundation agree to work together systematically for achieving the objectives as contemplated under this MoU.

1. Objectives and Scope of the Program

The objectives and scope of the program are detailed in **Annexure II - Objectives and Scope of the Program**.

2. Foundation's Roles and Responsibilities

The roles and responsibilities of the Foundation are detailed in **Annexure III - Foundation's Roles and Responsibilities** to this MoU.

3. Partner Institute's Roles and Responsibilities

The roles and responsibilities of the Partner Institute are detailed in **Annexure IV - Partner Institute's Roles and Responsibilities** to this MoU.

4. General Terms and Conditions

4.1 Term & Renewal

This MoU shall be effective from the **Effective Date** as mentioned above until **3 (Three) years** or completion of the Program activities as mentioned under this MoU or terminated as per the terms of this MoU, whichever is earlier. This MoU may be renewed by providing the other Party prior written notice of thirty (30) days and on mutual agreement of Parties in writing.

4.2 Termination

a) Either Party may terminate this MoU by providing the other Party with prior written notice of Sixty (60) days. Partner Institute shall ensure that no enrollments by Partner Institute/students/candidates are valid beyond the termination notice period. In the event any enrolment is valid post the termination notice period, Foundation may at its sole discretion & without prejudice may provide support until the enrolled course completion, subject to Partner Institute fulfilling its roles and responsibilities under this MoU.

b) In the event of any Party failing to fulfil its obligations as contemplated under this MoU, the other Party may notify in writing to cure such breach within thirty (30) days, failing which this MoU may be terminated forthwith at the option of the notifying Party.

4.3 Financial Terms

a. Each Party will bear the costs and expenses for fulfilling its respective roles and



## 1. OBJECTIVES OF THE MOU

- 2.6 Workshops, Webinars, Seminars and Events

## 6. NON- EXCLUSIVITY

The relationship of the Parties under this MOU shall be non-exclusive and both the Parties, including their affiliates, subsidiaries, and divisions, are free to pursue other MOUs or collaborations of any kind.

## 7. TERMS AND TERMINATION

This MOU shall be valid for the period of three (3) years from date to date. This MOU may be amended or terminated earlier by mutual agreement of the Parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 30 days prior written notice to the other Party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any research agreements executed before such termination of the MOU. Neither party shall be entitled to any compensation in the event of termination of this MOU.

## 8. GOVERNANCE AND PROGRAM MANAGING COMMITTEE (GPMC)

The following organizational structure is proposed for both Parties.
